

GENERAL TERMS AND CONDITIONS OF SPECIAL OFFERS

1. The following Terms and Conditions (hereinafter referred to as “**Terms and Conditions**” or **this “Terms and Conditions**”) define and stipulate the general rules guiding ‘Special Offers’ provided by BEAPCapital Limited (hereinafter referred to as the "**Organiser**") with registered office at BEAPCapital Limited, No. T2 Alibro Atrium, 32 Ekukinam Street, Utako, Abuja, Nigeria.
2. Special Offers as may be provided by Organiser shall mean and includes the following:
 - a) special prices – this implies offering prices lower than the current prices of some selected category of products by the Organiser within a specified period of time ;
 - b) special offers on shipping fees – this implies the Organiser being responsible to pay part or full shipping fees for goods of a particular value purchased within a specified period of time;;
 - c) special gifts – this implies gifts provided by the Organiser after purchasing products from a selected category of products of a particular value within a specified period of time;
 - d) Discount Code – this implies discount code for next purchase from the Organiser granted to a customer conditionally or unconditionally .
3. Special offers shall be provided by the Organiser in accordance with the principles set out in these Terms and Conditions and as amended by announcements provided by the Organiser, sent via the Organiser Newsletter, sent via e-mail, or published in other forms and should the terms of a particular special offer differ from the rules defined in this Terms and Conditions, the terms in the Special Offer shall prevail.

4. The specified period of time within which a Special Offer is to be utilized or any extension or abridgment of such period by the Organiser shall be referred to as “the Validity Period” of the Special Offer.
5. An announcement of a special offer shall be comprised in the “**Special Offer Notice**” which shall define and detail in particular the character, conditions for participation and timeframe of the Special Offer as well as the territorial scope and the group of the Organiser’s customers that the offer is applicable to
6. The Organiser reserves the right to cancel or amend or modify as it deems fit any special offer at any time without notice.
7. Participation in special offers is free of charge and voluntary.
8. Participation in special offers is open to a natural person, legal entities, or statutory bodies (hereinafter referred to as a "Participant"), after satisfying all of the following conditions:
 - a) They have a customer account or end user account in the organiser’s sales system;
 - b) They have read and accepted in full the provisions of these Terms and Conditions;
 - c) They have a place of residence or registered office in the territory covered by a particular special offer with limited territorial scope;
 - d) They are members of a group of the Organiser’s customers to whom the particular special offer is addressed, in case of special offers applicable only to selected categories of customers;
 - e) They have satisfied all the conditions of eligibility for a Special Offer defined in the Special Offer Notice and in these Terms and Conditions;
 - f) The Participant and the Organiser has entered into a sales or delivery agreement for goods that the Organiser offer’s.
9. Except as otherwise stated in the Special Offer Notice:
 - a) Special Offers are applicable to customers placing orders in any available form;

- b) the validity period of Discount Code and the rules of redeeming it shall be as stated in the Special Offer Notice. Special offers cannot be combined with one another or with any other discounts or individual discounts;
- c) Special prices do not apply to shipping fees;
- d) the Participant eligible to receive gift shall receive the gift only once and the gift shall be added to a parcel with the goods ordered, or delivered to the Participant in a separate parcel at the expense of the Organiser.

10. Sales of goods covered by a Special Offer by the Organiser shall be in accordance with the Organiser's sales terms and conditions, unless otherwise agreed or varied in writing.

11. These Terms and Conditions are governed, construed and regulated by the laws of the Federal Republic of Nigeria.

12. The Organiser reserves the right to alter the provisions of these Terms and Conditions as well as terms and conditions of a particular Special Offer for a significant reason in accordance with applicable laws and any such alterations shall be included in the form of an addendum to these Terms and Conditions and shall be an integral part of these Terms and Conditions.
